## FAQ

**Q. Is the WOW Sale offer combinable with the NextCruise<sup>SM</sup> offer? What are onboard guests being offered if they book on October 4th & 5th, 2011?**

**A.** Our onboard future cruise consultants are able to offer the WOW Sale on October 4th & 5th, 2011. Guests will be able to choose whether to accept the NextCruise offer or the WOW Sale offer, whichever is more beneficial to them. They will not be able to combine the offers to get both OBCs.

**Q. Is the WOW Sale offer combinable with Crown & Anchor<sup>®</sup> Society Savings Certificates or Crown & Anchor Society Platinum and above balcony and suite discounts?**

**A.** The WOW Sale offer is not combinable with Crown & Anchor Society savings benefits; our Crown & Anchor guests have the choice of applying the offer which is more beneficial to them.

**Q. Is the WOW Sale offer combinable with Future Cruise Credit (FCC) and Letter of Credit (LOC)?**
